Swanton Village Ordinance Updates

The legal residents and qualified voters of the Village of Swanton are hereby notified that the Board of Trustees of said Village on the <u>13th</u> day of <u>January 2025</u> unanimously voted to adopt the following Ordinances within said Village: Park Ordinance, Parking Ordinance and Water Rules and Regulations Ordinance. The said Ordinances may be disapproved by a vote of a majority of the qualified voters of Swanton Village voting on the question at an annual or special meeting duly warned for the purpose, pursuant to a petition signed and submitted by not less than five percent (5%) of the qualified voters of Swanton Village and presented to the Board of Trustees or Clerk within forty four (44) days following the date of adoption of the Ordinance by the Board of Trustees. Unless such a petition is submitted, the above-mentioned Ordinances shall become effective sixty (60) days after the date of adoption. Concerning the Regulation of the Village Parks enforcement the following sections have been added, deleted or amended to the Swanton Village Park Ordinances:

SECTION 1: Definitions

Removed Section 5. "Tacquahunga Park" as it is no longer owned by the Village of Swanton

Added: "8.) Taylor Drive Park"

Being a 0.03 acre parcel of land, triangular in shape located at the entrance of Taylor Drive, in said Village of Swanton.

Concerning the Regulation of the Parking Ordinance enforcement the following subsections have been added, deleted or amended to the Swanton Village Parking Ordinances:

Added Section 5503B. Church Street Parking Restriction.

No person shall park any vehicle on the southerly end of Church Street alongside the Village Green or the Town Clerk's Office.

Added Section 5504A. Parking Time Limited on Certain Streets.

Reenacted Two Hour parking limit from Monday – Saturday, 8 a.m. to 6 p.m. on certain Village Streets in downtown area.

Concerning the Regulation of the Water System Rules and Regulations Ordinance enforcement the following sections have been added, deleted or amended to the Swanton Water Rules and Regulations Ordinance:

Updated Definitions, Use of Swanton Village Water System and Water Rates and Charges sections.

These ordinances are made pursuant to and in conformity with the Charter of Swanton Village, as amended, and in accordance with Statutes of the State of Vermont.
